Vercal

A unique formulated blend of calcium, complexed with lignosulphonates and adjuvants for improved tank-mix compatibility

Contains 150g/l Calcium

Directions for Use:

Application Rate: Use 2.5 - 5.0 litres in 200 litres water/ha. Repeat applications may be necessary where moderate to severe deficiency is known or as identified by analysis.

Application Timing:

Potatoes: Apply 5 I/ha at tuber initiation. Repeat applications at 10 - 14 day intervals as advised or recommended by analysis.

Sugar beet: Applications start with 2.5 I/ha when enough foliage to absorb the spray. Repeat as necessary during the tuber growth stage.

Carrots, Celery: apply 2.5 I/ha when symptoms of deficiency are first seen. For carrots: repeat 2 - 3 applications at 10 - 14 day intervals beginning at the pencil stage.

Lettuce, cabbage, etc...: Spray 2.5 I/ha early in the growing season and repeat every 10 -14 days as necessary.

Tomato, pepper, melon, water melon, strawberries: Apply 2.5 - 5.0 I/ha according to the deficiency, from start of flowering. Repeat at 10 - 14 day intervals as necessary.

Apples, pears, peaches, apricot, etc ...: Apply 3-5l/ha from petal fall and repeat at 10-14 day intervals with a final application 10 - 14 days prior to harvest, depending on the cultivar. The exact rates and timings can be manipulated to suit local spraying practices.

Grapes: Apply 2-3 I/ha before fruit formation and then repeat 2-3 times during the fruit growth stage till before the harvesting.

Other Crops: Susceptible to calcium deficiency, apply as early in the growing season as possible provided there is adequate leaf cover.





Mixing:

Shake the container well before opening. Three-quarters fill the spray-tank with water and add slowly to the tank with agitation. Rinse the container thoroughly, add the rinsings to the spray-tank, complete the filling and apply without delay. Empty the container completely and dispose of safely.

Compatibility:

Vercal is physically and chemically compatible with a wide range of agrochemical products. Consult your supplier or Headland Agrochemicals Ltd. for the latest information.
